THREADED\_EXECUTION=TRUE: Oracle runs with the multithreaded model. \* OS Authentication is not supported with the multithreaded model. \* THREADED\_EXECUTION When this initialization parameter is set to TRUE, which enables the multithreaded Oracle model, operating system authentication is not supported. Attempts to connect to the database using operating system authentication (for example, CONNECT / AS SYSDBA or CONNECT / ) when this initialization parameter is set to TRUE receive an ORA-01031 "insufficient privileges" error. The Master Table is created in the schema of the current user running the Pump Dump export or import, and it keeps tracks of lots of detailed information. The Automatic Workload Repository (AWR) Compare Periods report enables you to compare database performance between two periods of time. While an AWR report shows AWR data between two snapshots (or two points in time), the AWR Compare Periods report shows the difference (ABE) between two periods (or two AWR reports with a total of four snapshots). Using the AWR Compare Periods report helps you to identify detailed performance attributes and configuration settings that differ between two time periods. When automatic SQL tuning is in COMPREHENSIVE mode, it runs a verification or evolve process for all SQL statements that have non-accepted plans during the nightly maintenance window. If the non-accepted plan performs better than the existing accepted plan (or plans) in the SQL plan baseline, then the plan is automatically accepted and becomes usable by the optimizer. After the verification is complete, a persistent report is generated detailing how the non-accepted plan performs compared to the accepted plan performance. Because the evolve process is now an AUTOTASK, DBAs can also schedule their own evolve job at end time. Note: \*The optimizer is able to adapt plans on the fly by predetermining multiple subplans for portions of the plan. \*Adaptive plans, introduced in Oracle Database 12c, enable the optimizer to defer the final plan decision for a statement until execution time. The optimizer instruments its chosen plan (the default plan) with statistics collectors so that it can detect at runtime, if its cardinality estimates differ greatly from the actual number of rows seen by the operations in the plan. If there is a significant difference, then the plan or a portion of it will be automatically adapted to avoid suboptimal performance on the first execution of a SQL statement. Note: \*The contents of ASM files are stored in a disk group as a set, or collection, of data extents that are stored on individual disks within disk groups. Each extent resides on an individual disk. Extents consist of one or more allocation units (AU). To accommodate increasingly larger files, ASM uses variable size extents. \*The size of the extent map that defines a file can be smaller by a factor of 8 and 64 depending on the file size. The initial extent size is equal to the allocation unit size and it increases by a factor of 8 and 64 at predefined thresholds.
