Explanation: A new address type made specifically for IPv6 is called the Anycast Address. These IPv6 addresses are global addresses, these addresses can be assigned to more than one interface unlike an IPv6 unicast address. Anycast is designed to send a packet to the nearest interface that is apart of that anycast group. The sender creates a packet and forwards the packet to the anycast address as the destination address which goes to the nearest router. The nearest router or interface is found by using the metric of a routing protocol currently running on the network. However in a LAN setting the nearest interface is found depending on the order the neighbors were learned. The anycast packet in a LAN setting forwards the packet to the neighbor it learned about first.

Explanation: Subnetting is used to break the network into smaller more efficient subnets to prevent excessive rates of Ethernet packet collision in a large network. Such subnets can be arranged hierarchically, with the organization's network address space (see also Autonomous System) partitioned into a tree-like structure. Routers are used to manage traffic and constitute borders between subnets. A routing prefix is the sequence of leading bits of an IP address that precede the portion of the address used as host identifier. In IPv4 networks, the routing prefix is often expressed as a "subnet mask", which is a bit mask covering the number of bits used in the prefix. An IPv4 subnet mask is frequently expressed in quad-dotted decimal representation, e.g., 255.255.255.0 is the subnet mask for the 192.168.1.0 network with a 24-bit routing prefix (192.168.1.0/24).

An example of an IPv6 address is 2001:0db8:85a3:0000:0000:8a2e:0370:7334. The leading 0's in a group can be collapsed using ::, but this can only be done once in an IP address.

The network used for point-to-point connection should be /30. So our initial network should be $2^7 = 23$. So 10.10.0.0/23 is the correct answer. You can understand it more clearly when writing it in binary form: /23 = 1111 1111.1111 1110.0000 0000/30 = 1111 1111.1111 1111.1111 1100 (borrow 7 bits) QUESTION 90 A Cisco router is booting and has just completed the POST process.
