 * Lync Server makes extensive use of SQL Server databases, ranging from the Central Management

store to the Archiving database. As a general rule, these databases are set up at the same time you install Lync Server or at the same time you install a Lync Server role (such as Monitoring Server) that requires a database back end. After installation has taken place these databases typically will not need to be reinstalled or moved to new locations. On rare occasions, however, you might need to manually install a Lync Server database; this could be because you need to move a database to another server, or because a setup-related problem failed to install the database for you. The Install-CsDatabase cmdlet provides a way for you to install any of the SQL Server databases used by Lync Server.* Invoke-CsPoolFailbackInvokes the failback process for a Lync Server 2013 pool. Failback is used after a pool has failed over and the users of that pool have been "failed over" to a backup pool. (That simply means users who were signed on to the failed pool are automatically signed on to the backup pool.) When the failed pool has been restored, the fail back process signs the failed-over users back to their original pool.*Move-CsManagementServerMoves the Central Management Server from one pool to another. 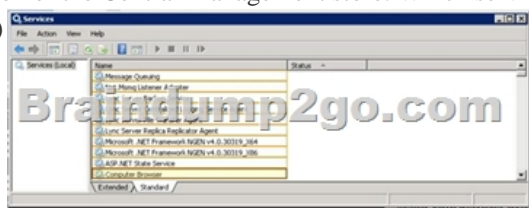

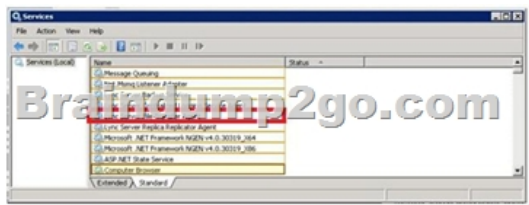
